

**Cromwell Area Community Club**  
**April 6, 2023 Meeting Minutes**

A motion was made by Lynn, seconded by Sharon to approve the minutes from the March 2, 2023 meeting as presented, with one correction. All in favor, motion carried.

Treasurer's Report – Brenda presented the March 2023 financial reports noting the report reconciles to bank statements and also reflect earmarked funds for picnic tables (\$5,000) and 2023 Chilloween (\$198.23). Mayor's Update – The report sent out by the city stated that there is manganese in the city water. This is the same as it has been. It is safe to drink. Following the Health Guidelines of Value, it said it is safe. Box culverts will be replaced this summer between Cromwell and Wright. The box culvert that splits Upper and Lower Island Lake just outside of Cromwell will be replaced July 5-July 27. A detour will be in place. The box culverts by Woodbury Lake and the Tamarack River. The Hwy. 73 corridor meeting was rescheduled for April 12, 5:00 p.m. @ the pavilion.

**OLD BUSINESS:**

The CACC received the LCP Operation Round Up Grant for \$1,000 for the ice skating rink.
